## OUR WATERSHED, OUR AMBASSADOR

**Do you know what a watershed is?** The New Jersey Watershed Ambassador Program (NJWAP) is a community-oriented AmeriCorps program created to raise awareness about watersheds and watershed issues in New Jersey. Through this program, twenty AmeriCorps members are each placed in one of twenty Watershed Management Areas within the state to serve their local communities. Each AmeriCorps member is responsible for monitoring the waterways and educating the communities within their specific watershed.

A watershed is an area of land that drains to a specific body of water, such as a river, lake, stream, or bay. The residents of Bordentown City live in **Watershed Management Area 20**, which is the **Doctors, Assiscunk, and Crosswicks Watershed**. WMA 20 also includes smaller Inner Coastal Plain watersheds that eventually drain to the Delaware Estuary below Trenton. It encompasses **253 square miles with 27 municipalities**, and includes parts of **Burlington, Mercer, Monmouth, and Ocean counties.** WMA 20 is bordered on the west by the Delaware River, on the north by Trenton and Route 195, on the east by Six Flags Great Adventure and Colliers Mill Wildlife Management Area, and on the south by Fort Dix and McGuire military bases.

Watershed Ambassadors are trained to monitor the water bodies of New Jersey through visual and biological monitoring protocols. The members are also available to work with and/or train community volunteers in these protocols. Aside from stream monitoring training, the ambassadors can also work with the community to organize stream clean-ups, storm drain markings, tree plantings, and other activities. Watershed Ambassadors are also available to make presentations to community and civic groups, as well as to school groups. The interactive hands-on presentations provide information about water and watershed issues in New Jersey. Along with educating students and citizens about water and watersheds, the members also empower them to get involved in their own watersheds.

The NJDEP Division of Watershed Management began hosting this environmental AmeriCorps program in September 2000. The watershed program works to improve the quality of New Jersey's waterways, and therefore improve the quality of life in New Jersey. The program also works to improve water quality by exploring relationships between people and the environment, facilitating community-based environmental activities, and empowering residents to make responsible and informed decisions regarding their watersheds.

#### **Thorntown Creek Greenway Update**

BCEC has applied for a NJ Recreational Trails Grant to develop a nature trail along Thorntown Creek, with access from Elizabeth Street. The property behind Gilder baseball field is owned by the City, and is a lovely stretch of wooded floodplain that extends from Rt. 206 to Elizabeth Street. The grant seeks to create a walking trail along this section of the Creek (future plans include extending a greenway trail all the way to Crosswicks Creek). The grant is for \$10,000, with \$2,500 to be matched by the City in the form of in-kind (volunteer) labor and services. The grant seeks funding for interpretive signage, trail markers, several benches, a bicycle rack, and bollards to prevent vehicle access from Elizabeth Street. Notification of the grant will be in September. However, BCEC will be scheduling a Trail Work Day in the summer or fall to start the process of laying out and constructing the trail itself.

The Burlington County Environmental Health Committee will be holding an Environmental Health Conference on March 24, 2007 from 9:00am-1:00pm at the Rutgers EcoComplex 1200 Florence-Columbus Road Bordentown.

The conference will feature radio personality Mike McGrath, the host of "You Bet Your Garden" on WHYY. Mr. McGrath will be discussing home composting and the use of natural remedies over pesticides and insecticides. In addition to Mr. McGrath, attendees will receive an update on the environmental health of Burlington County and a discussion on lead poisoning prevention. A special highlight of the day is a tour of the tilapia and hydroponic tomato research that is being done at the center.
