VI-Grants

Assisted Delaware Riverkeeper Network with application for \$5,000.00 grant from NJ Fish & Wildlife Landowner Incentive Program for endangered plant and animal habitat restoration along lower reach of Thorntown Creek in 2007. Grant received in August 2006. No City matching are funds required. BCEC will assist in coordination of volunteer and outreach efforts.

Applied for \$12,000 NJ Recreational Trails grant for trail development along Thorntown Creek between Gilder Field and Elizabeth Street. Grant will fund trail building, interpretive signage, benches, and security fencing. City match is in-kind services. Grant work may be completed in 3 years.

Conducted eleven regular monthly meetings at Carslake Community Center (August canceled).

II-Outreach & Education

Received input from, and addressed concerns of, Bordentown City residents at regular monthly meetings.

Created/published 4 editions of BCEC newsletter, containing articles and information designed to inform and educate City and area residents about local environmental issues. Distributed newsletters at annual Street Fair and Cranberry Festival, posted on City Hall bulletin board, and distributed to several local businesses. Newsletters were also distributed via e-mail to BCEC mailing list. (See Appendix)

Staffed exhibit table at the Bordentown Street Fair & Cranberry Festival. Distributed environmental education material. Created and presented educational exhibit regarding



local environmental issues, including Bordentown the City Bicycle/Pedestrian Plan, Bordentown City Open Space Plan, Bordentown City Conservation Element, and other local issues. Gathered names/addresses for database of volunteers. Conducted free raffle of two compost bins and distributed composting information at both events.

Maintained BCEC website. Linked web site to other environmental organizations. The web site contains BCEC newsletters, links to local organizations, and photos of BCEC events and topics of local interest. The website receives approximately 100 hits/month.

Participated in ongoing Crosswicks Creek/Doctor's Creek Greenway regional study. This project includes five municipalities in our region, including Hamilton, Allentown, North Hanover, Plumsted and Chesterfield. Provided information and evidence as to importance of inclusion of Bordentown City in this process.

Conducted a "visioning process", which produced a long-range plan for BCEC projects and activities. Top, Medium and Low tier priorities were identified, and subcommittees were created for high priority issues, including Outreach, Parks/Trails and Recycling.

Attended ongoing Burlington County Route 206 Corridor Study meetings.

Participated in ongoing State Plan Cross-Acceptance process via Burlington County oversight.

Liaised with Delaware & Raritan Greenway and Delaware & Raritan Canal Commission regarding upcoming project to construct multi-use canal path extending from Bordentown City to Trenton.

Initiated request to NJDOT for landscaping enhancement for Bordentown City. Coordinated request with Bordentown City Shade Tree Committee for approximately \$27,000 worth of diseased tree removal and new plantings at Gilder Field, including the planting of 36 three-inch caliper trees in Spring 2006.

Maintained 5 pet waste bag dispensers at various City locations. Ordered additional bags for 2007.

Public Events

Conducted an Earth Day Stream Cleanup (April) of Thorntown Creek, between Elizabeth Street and railroad tracks. Collected dozens of bags of garbage and over 1000

Responded to residents' inquiries regarding various pounds of miscellaneous refuse, which was removed by Public Works Department.

> Conducted an Open Space Tree Planting (May) of 150 tree seedlings as part of the reforestation of newly acquired open space on Oliver Street. Trees were obtained at no cost through grant from NJ Tree Foundation.

> Conducted a Storm Drain Labeling (May) project, affixing 50 storm drain medallions ("No Dumping, Drains to Creek"). Another 60 medallions will be installed in 2007.

> Conducted an Invasive Plant Species Removal (June) project, with volunteers removing non-native vegetation (purple loosetrife) from area along Blacks Creek at Bordentown Beach. Also, coordinated similar effort in Bordentown Township with Twp. Environmental Commission on same day.

> Conducted a Native Plant Restoration (September) project, planting over 60 native wetlands plants (alders, dogwoods) along Blacks Creek at Bordentown Beach.

> Conducted an Open Space Ramble (October), highlighting several recent and proposed open space acquisitions, including Oliver Street/Real Property, Lime Kiln Alley, as well as Railroad Avenue Promenade. Distributed Special Places of Bordentown City brochure/map to attendees.

> Held inaugural Earth Talk (November), a periodic speakers series on environmental issues. The first Earth Talk topic was "Get to Know Your Local Environment", a photographic tour of Bordentown City's natural areas, plants and wildlife.

> Held a public meeting on residential and commercial recycling in Bordentown City (November). Liaised with Burlington County Office of Solid Waste Management & Recycling Office regarding increasing local recycling efforts.

BCEC Chair made presentation on "Environmental Commissions Speaking Out" seminar at annual ANJEC Environmental Congress.

BCEC member attended 2-day Leadership Training by Association of NJ Environmental Commission Congress.

Conducted stream monitoring of local waterways, including Blacks Creek, Thorntown Creek and Love Bridge Run. Testing included pH, electrical conductance, dissolved oxygen, phosphates, and nitrates/nitrites. This is expected to be an ongoing monitoring effort, with results shared with regional environmental agencies. (see Appendix)
